OFFER OF ADMISSION – TERMS AND CONDITIONS

You are required to communicate your offer of acceptance **within three days** of receiving the mail for admission, failing which, your offer of admission stands cancelled and the offer will be given to the next candidate in the waiting list.

Admission offer is valid subject to the following conditions:

1. He / she should have passed the entry qualification examination.
2. He / She shall produce the original/provisional qualifying certificate at the time of admission.
3. Fulfillment of qualification and other eligibilities are based on the verification of original certificates/testimonials.
4. Medical Fitness Certificate should be produced at the time of admission in the prescribed format on self declaration basis* (*on requirement, the same may be provided from a medical practitioner not below the rank of Asst. Surgeon from any Government hospital at the time of reporting to college).

At the time of admission, the following documents have to be produced in ORIGINAL.

1. All the Original mark sheets of entry qualification.
2. Passing / Provisional / Degree Certificate.
3. Transfer Certificate.
4. SC/ST Certificate (if applicable)
5. OBC (Non-Creamy Layer) certificate (if applicable).
6. EWS Certificate (if applicable).
7. Current parental Annual Income Certificate as per the conditions stipulated (copy enclosed).
8. Four passport size photographs.
9. Undertaking duly signed by him/her and parent in the enclosed form.
10. Appropriate certificate for Physically Challenged Candidate as a proof for claim.
11. Proof of deposit of Admission fees through on-line.
12. Medical Fitness Certificate as per the format*.

The candidate should be in a position to pay all the required fees and deposits on the date of joining.

Limited hostel accommodation is available at centre. Allotment of hostel accommodation is on need basis and as per the availability for the outstation students.

ANNEXURE-II

CODE OF CONDUCT & DISCIPLINE

The Students are expected to maintain a high standard of discipline

1. The following are deemed to be acts of indiscipline:
 - I. Disregard of order and instructions of the members of the institute staff
 - II. Disregard of institute/hostel rules, orders and notices.
 - III. Improper Usage/Damage of institute property
 - IV. Irregular attendance and unauthorized absence from classes and hostel
 - V. Lack of punctuality, payment of all dues and other matter where date and time for any dues, function or obligation are prescribed
 - VI. Persistent neglect of studies and assignments.
 - VII. Habitual illness.
 - VIII. Failure to wear the prescribed uniform & shoes during working hours,
 - IX. Failure to produce identity card on demand by staff, warden etc, at any time within the institute/hostel premises
 - X. Recourse to false or fraudulent statement or acts.
 - XI. Recourse to unfair means in tests & examinations.
 - XII. Possession of stolen properties, committing theft, engaging in consumption of drugs & liquor, gambling and involving/abetting in any unlawful activities.
 - XIII. Unsportsman like behavior in indoor and outdoor games.
 - XIV. Noisy, boisterous, disorderly and disrespectful behavior inside and outside the institute/hostel
 - XV. Ragging in any form inside and outside the institute/Hostel Premises
 - XVI. Taking part in demonstration, strikes in and outside the institute/Hostel Premises
 - XVII. Failure to report Indiscipline cases to the institute authorities.
2. Student shall be responsible for the machinery/equipment allotted to them and ensure their proper utilization and upkeep of machinery.
3. Student shall be responsible for all books, apparel, tools, instruments, materials, etc, issued to them.
4. Student who are awarded stipend shall execute a bond
5. Students shall observe all safety precautions. The Institute is not responsible for accidents of whatever nature in the institute, hostel, workshop, laboratory, and playground and at any other place.
6. No society, association or club shall be formed by the students without the prior permission of the Centre-in-charge.
7. No meeting shall be convened and no person shall be invited to address any meeting in the institute/hostel premises without the prior permission of the Centre-in-charge.
8. Students who are found to have committed any act of indiscipline are liable for any one or more of the following punishments:
 - (i) Warning (ii) Censure (iii) Fine (iv) Reduction/cancellation of stipend (v) Recovery in part or full of losses or damages to the institute property or property of other caused by the delinquent students (vi) Suspension from availing of any the institute amenities and services or from classes (vii) Removal, Rustication or expulsion from the institute, hostel or mess (viii) Withholding of conduct/character certificate.

Ragging is Prohibited as per the decision of the supreme court of India in Writ Petition No.(c) 656/1998 Ragging in any form will invariably lead to expulsion from the institute and Hostel.

The punishments are liable to be inflicted summarily at the discretion of the Centre-in-charge, whose decision shall be final.
