#### **TERMS & CONDITIONS**

- 1. The components should be machined as per the Geometrical & Dimensional Tolerances specified. Internal QC report should be provided for each job.
- The raw material will be provided by CIPET: IPT, Ahmedabad. In case of rejection, the same raw material has to be compensated by the vendor with same grade of material. Raw Material Test Certificate (Mechanical & Chemical) from NABL approved laboratory has to be provided compulsorily.
- 3. 2D Drawing/3D Models will be provided by CIPET: IPT, Ahmedabad. 2D Drawing should be used for machining as per tolerance. 3D model is for reference purpose. In case of doubt, vendor is requested to inform/contact CIPET: IPT, Ahmedabad for clarification in drawings before proceeding for machining.
- 4. The successful vendor has to submit the Bank Guarantee of Rs. 1,50,000/- on award of Work Order for Precision Machining Work. The Bank Guarantee may be forfeited in case of rejection or loss of raw material.
- 5. The payment will be processed post satisfactory acceptance of supplies (precision machining work) by Toolroom Department of CIPET: IPT, Ahmedabad.
- 6. The vendor should meet the delivery schedule without fail. Otherwise, penalty will be imposed as per the terms and condition and EMD & Bank Guarantee will be forfeited.
- 7. The vendor should have sufficient machining and measuring facilities for execution of the jobs in specified duration.
