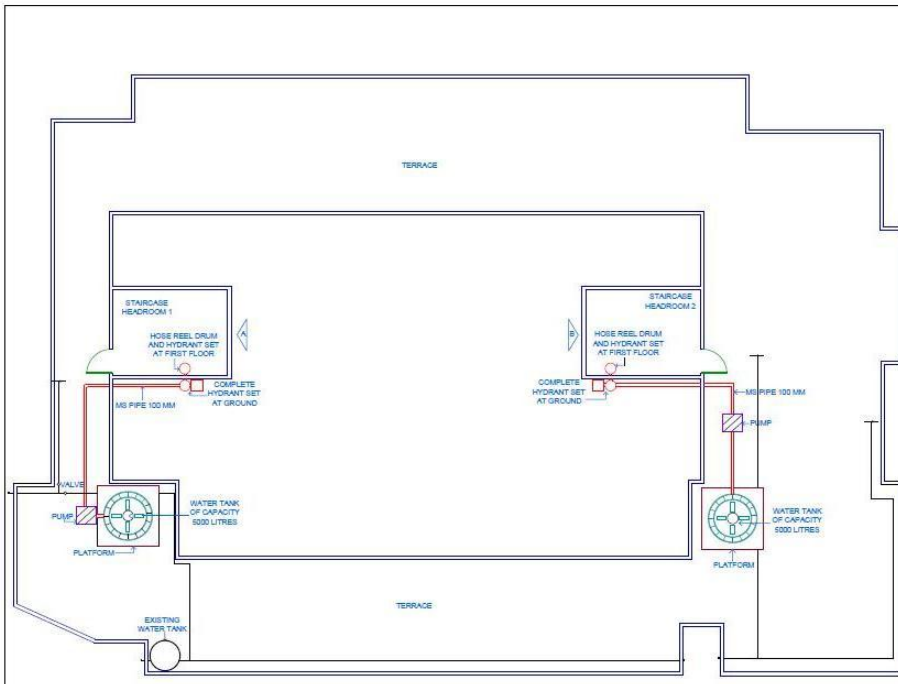

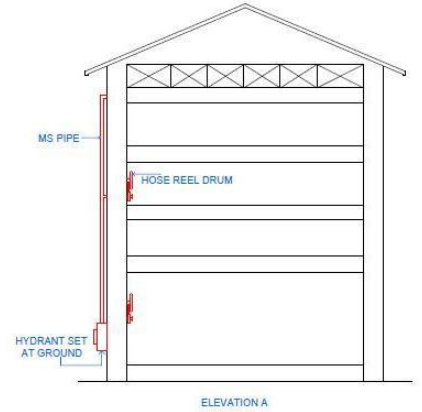

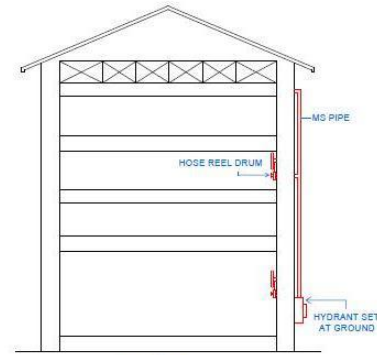

SPECIAL TERMS AND CONDITIONS / INSTRUCTIONS TO BIDDER

1. The Tenderer is expected to examine all instructions, forms, terms and specifications in the Tender Documents. Failure to furnish all information required for the Tender Documents or submission of a Tender not substantially responsive to the Tender Documents in every respect will be at the Tenderer's risk and may result in rejection of the Tender.
2. Interested Bidders are advised to visit the site in their own interest before quoting the rates. Request for escalation for whatsoever reason shall not be entertained in any case.
3. CIPET CSTS Guwahati shall not be liable for any expenses whatsoever incurred by the Tenderer for interim visit to site for inspection and in the preparation of the tender whether his tender is accepted or not even for complete withdrawal of invitation of the Tender.
4. Offer should be in two parts Viz., "**TECHNICAL BID**" and "**FINANCIAL BID**" and all bids must be submitted through the online portal **www.tenderwizard.com/CIPET** Only.
5. Any Tender received by the Purchaser after the deadline for submission of E-Tenders prescribed by the Purchaser, will be rejected. Conditional tender will be summarily rejected without prejudice so bidders are advised to quote the price as per N.I.T. conditions only.
6. Tenders shall remain valid for 180 days after the date of E-Tender.
7. The items should be supplied within 30 days time from the date of issue of the Purchase Order / Work Order.

 - b) After acceptance of his tender, the Tenderer fails to take up the job.
