# Essential Requirements for the EOI

## 1. Minimum Eligibility of the suppliers

## a) For Stitched Uniforms:

- Suppliers should have minimum two years of experience of tailoring/stitching of official uniforms in bulk to the Departments/Ministries of the Government of India/PSUs/Corporates/Engg. Colleges/Schools. etc. (two copies of work orders received during each of the last two years should be enclosed);
- II. Should have minimum turnover of Rs. 3 lakh per year during each of the last two years (valid and certified proof has to be attached);

## b) For Shoes/Bags:

- Suppliers should have minimum two years of experience of supplying Bags/Shoes in bulk to the Departments/Ministries of the Government of India/PSUs/Corporates/Engg. Colleges/Schools. etc. (two copies of work orders received during each of the last two years should be enclosed);
- II. Should have minimum turnover of Rs. 2 lakh per year during each of the last two years (valid and certified proof has to be attached);
- c) Should not have been blacklisted by the Depts./Ministries of the Govt. of India/PSUs/ Engg. Colleges/Schools. Etc. (declaration has to be submitted in the format as Annexure -1).

## 2. EOI Prices

a) The rates/ prices should be quoted in Rupees (INR) only in words as well as in figures. Taxes, if any, should be indicated separately. **No additional freight charges will be paid**.

#### 3. Submission of EOI

#### a) Sealing, Marking & Submission

- i. **Envelope No.1**shall contain, Declaration (Annexure I) and Vendor Registration Form with all the required documents. A covering letter may also accompany the same.
- ii. Envelope No.2shall contain the samples of accessories i.e. Cloths for pants & shirts, Thread, Lining, Zip, Inter- lining, Fuse lining, Pad, Chest piece, Buckram, Buttons/ A Pair of Shoes& Socks and a Bag for reference (Samples of unsuccessful Supplier/ Provider may be returned back).
- iii. Envelope No. 3 shall contain the prices as in Annexure III.
- iv. All the above three envelopes are packed in a **fourth Envelope** (packed and marked) and addressed to CIPET: CSTS, Dehradun and must reach on or before the **15.03.2019 by 05.30 PM**.
- **b)** All the above envelopes shall bear the Name of the Work *viz*. 'EMPANELMENT OFSUPPLIERS / PROVIDERS OFSTITCHEDUNIFORM, BAGS, SHOES, SOCKS FORSHORT TERM COURSE STUDENTS OF CIPET: CSTS, DEHRADUN'.
- c) All the envelopes shall indicate the name and address of the Supplier / provider to enable the EOI to be returned unopened, if required.

#### 4. Mode of Payment

- a) Payment against Bill/Invoice shall be released only after execution/supply of the uniforms as per specification and submission of the Bill/Invoice through A/c Payee Cheque/NEFT ONLY.
- b) The measurement for stitching the uniform of eligible students shall be taken for by the tailoring firms themselves in the CIPET: CSTS, Dehradun on day/days so fixed by the competent authority.
