TENDER TERMS & CONDITIONS

- 1. Sealed tenders invited from experienced, resourceful and reliable Companies/Agencies/firms of repute for "outsourcing of manpower" (High Skilled / Skilled /Semi-Skilled/Unskilled) who has provided/providing manpower to various organizations having valid EPF and ESI code number, GST Registration and Labour Licence issued by the office of the Chief Labour Commissioner, Ahmedabad may submit the Tender along with updated list of their clients. The agencies/firms/companies, who are providing services in the Gujarat State will only be considered for this tender purpose and the firm is having establishment office in Ahnmedabad, Gujarat with registration of the state authority only will be considered.
- 2. The period of contract under the scope of work shall be normally be for 12 months, which can be further extended on mutually agreed terms & conditions. The máximum duration of the contract will be 03 years, which will be renewable on yearly basis subject to providing satisfactory services.
- 3. The Agency has to execute the work/contarct as per the requirement of the institute.
- 4. The contractor will provide the identity cards and uniform to each staff at their own cost (2 sets every year) after getting approval from CIPET: IPT, Ahmedabad's management and the employee should wear the same during duty hours.
- 5. As per the need of the organization, the employee has to execute the work. The employee has to stay beyond the working hours in case of exigencies of work. Some jobs are subject to tenure basis, specifically as per the need of the organization.

- 3. The Agency has to quote Service charge (In Rupees & Words) only in the financial bid. The monthly wages will be paid as per the mínimum wages notified by Government of Gujarat from time to time.
- 4. The firm/company will pay the employer's contribution towards Employees Provident fund (EPF) (as applicable) and Employees State Insurance (ESI) (as applicable), GST and all taxes/ charges levied under statutory provisions (subject to Govt. Revision) which will be reimbursed to the agency/firm/Company on submission of the actual bill payment copy.

- 6. Manpower for various works should be made available. The Manpower shall be able to perform various works as well as field duties as and when required.

- 7. The personnel deployed by the Agency will be on the rolls of the Agency in all respects. CIPET: IPT, Ahmedabad will not take any responsibility whatsoever in regard to the personnel deployed by the Agency. The firm will fully indemnify CIPET: IPT, Ahmdebad in this respect.
- 8. The Agency should ensure the payment of wages to be done to their staff through Bank tarnsfer/NEFT/RTGS only.
- 9. The selected Agency has to enter into an agreement on Non Judicial Stamp of Rs 100/- at their own cost with CIPET: IPT, Ahmedabad for period of one year, which can further be extended with the consent of both the parties.
- 10. The agency has to provide Bank Guarantee of Rs. 10,00,000/- (Rupees Ten Lakhs Only) valid for period of 02 years from the date of issue of Letter of Intent (LOI).
- 11. - 22. The personnel deployed by the agency should bear moral character duly verified by the pólice authority and of sound Physical and Mental health to carry out the work.
- 23. CIPET: IPT, Ahmedabad reserves the right to declare any person deployed by the agency as unfit for any work on account of not having proper efficiency, sound physical and mental health or creating nuisance and or any other valid reason and its decisión shall be final and binding on the service provider. Any deployment / change of the deployed employee should be with the consent of CIPET: IPT, Ahmedabad's authority.
- 24. If the Tenderer withdraws the offer after submission of the tender or fails to deploy the required personnel after acceptance of tender, CIPET: IPT, Ahmedabad reserves the right to forfeit the earnest money deposit/ encash Security Deposit so deposited and terminate the contract without any notice.
- 25. The contract may be terminated at any time without paying compensation whatsoever to the agency in the case of misbehavior, disobedience, dishonesty, clandestine insolvency, court order, cancellation of license or any other related activities on its failure to fulfill the terms and conditions of the contract. The decisión of the Principal Director & Head, CIPET: IPT, Ahmedabad will be final in all matters. The contarct can be terminated by either side - by giving 01 months notice from CIPET: IPT, Ahmedabad and 02 months notice from the agency side.
- 26. The successful tenderer shall produce all original documents connected with the contract before commencement of the work.
- 27. The DD of earnest money, copy of Registration Certificate, Labour License Certificate, EPF and ESI code no., GST registration and Documentary evidence regarding experience must be submitted with the tender. Service rendered at Govt./Semi Govt./Private organizations with number of personnel provided and duration of services may be mentioned separately.
- 28. Copy of service satisfaction certificate/Performance certificate of existing clients served/serving must be attached.
- 29. The wage rates shall be paid as per Department of Labour and Employment, Government of Gujarat applicable to Ahmedabad city. The wages shall be paid as per the existing rates including any change during the tenure of contract prescribed by the state government. EPF & ESI contribution payable for each person and the contractor's service charge, as per format of the mínimum wages for High Skilled, Skilled, Semi-Skilled and Unskilled person as per vide Ministry of Labour and Employment, Govt. of Gujarat, issued by Chief Labour Commissioner from time to time shall be paid.

GENERAL TERMS & CONDITIONS

- 1. The tenderer submitting tender would be deemed to have inspected the premises, considered and accepted all the terms and conditions of contract. No verbal or written enquiries will be entertained in respect of acceptance or rejection of the tender.
- 2. **Tenure of Services:** The contract will be for a period of one year initially with a trial period of 3 (three) months. If the services during the trial period are satisfactory, the contract will be renewed for the remaining period of 9 (Nine) months.
- 3. In case the firm/agency fails in fulfilling the obligations fully and in time, the CIPET: IPT, Ahmedabad shall have the absolute right to take up the work at the Contractor's cost and risk and recover any and all such expenses from the amounts due to the Contractor including Security Deposit. The Institute shall have right to impose penalty commensurate with the fault and amount towards damages if any, shall be recovered from the bill and/or security deposit.
- 4. The firm/agency will be fully responsible for any accident or mishaps involving staff engaged and the frim/agency will be liable to meet the claims. The firm/agency shall indemnify the CIPET: IPT, Ahmedabad from any claims arising out of accidents, disabilities of any nature or death or arising out of provisions under law, or any other nature in respect of all workers engaged by the firm/agency. The firm/agency will fully indemnify CIPET: IPT, Ahmedabad against all claims in this regard.
- 5. The Contractor shall abide by all laws and regulations and statutory obligations in force from time to time including labour laws and shall indemnify the CIPET: IPT, Ahmedabad from any claims in this regard.
- 6. It will be the sole responsibility of the firm/agency to abide by the provisions of the following acts as to the staff engaged by them for performance of this contract:
 - > Employment of Children Act
 - ➤ Workmen compensation Act
 - Contract Labour (Regulation & Abolition) Act 1970.
 - ➤ Minimum Wages Act
 - Employee Provident Fund Act & Misc. Provisions Act
 - ➤ ESI Act
 - Any other act or legislation as may be in force from time to time.
- 7. The firm/agency shall comply with all the statutes and will be responsible for any prosecution or liability arising from breach of any of these laws.

- 8. Any liability arising on the CIPET: IPT, Ahmedabad due to the firm/agency shall be deducted from the bills of the firm/agency and if the full amount is not recovered then the same shall be recovered from the security deposit of the firm/agency.
- 9. In case of items/fixtures stolen/broken due to the fault of the contract personnel, either the penalties to recover the cost shall be imposed or the firm/agency shall have a choice to replace these fixtures of the same quality & under approval from nodal officer appointed by CIPET: IPT, Ahmedabad.
- 10. **Modification of specification of work:** CIPET: IPT, Ahmedabad reserves the right of altering the specifications of works of adding to or omitting any items of work or of having portions of the same carried out in the Institute by others and such alterations and variations shall not violate this contract.
- 11. The firm/agency is required to comply the instructions received by the CIPET: IPT, Ahmedabad.
- 12. In the event of the firm/agency failing to execute the work during rendering services in whole or in part, an alternative arrangement will be made by the CIPET: IPT, Ahmedabad totally at the cost & risk of firm/agency besides any suitable fine /penalty.
- 13. The firm/agency shall be liable to pay compensation for any loss & damage caused to the property of the CIPET: IPT, Ahmeabad or its Staff Members/Students/Visitors by the firm/agency or its staff members.
- 14. The firm/agency shall be responsible for the conduct of its staff and in case of any complaint against any of his staff regarding work, discipline, attendance or any other matter concerning efficient and smooth functioning; the firm/agency will be under an obligation to change the staff.
- 15. **Resolution of disputes:** In the event of any dispute arising out of or in connection with this contract, whether during the subsistence of the contract or thereafter, the matter shall be referred to the Principal Director & Head, CIPET: IPT, Ahmedabad or any other officer nominated for arbitration whose decision shall be final and binding on the parties. The firm/agency agrees that the arbitrator could be an employee of the Institute & shall not have any objections in this regard. The proceedings before the arbitrator would be governed by the provision of the Arbitration Act 1996.
- 16. All letters posted to firm/agency at the address given by him will be considered to have been delivered in time.
- 17. The firm/agency's representative/owner should not be employee of CIPET: IPT, Ahmedabad, Central or State Government, Autonomous Body, or PSU. He should submit a declaration to this effect.

- 18. The contractor's staff will make their own residential arrangement outside the premises of the CIPET: IPT, Ahmedabad. No one will be granted permission to stay in the institute premises including Hostel during night or during non-working hours.
- 19. **Prohibition of leasing or sub-contracting:** The contractor shall not lease or sub-contract the whole or any part of the contract to anybody.
- 20. That payment on account of enhancement/escalation charges on account of revision in wages and statutory payments like EPF/ESI contributions, any tax only by the appropriate Govt. (Central/State) from time to time shall be payable by the CIPET: IPT, Ahmedabad to the contractor. No escalation of Service Charges of Contractor's shall be admissible during the term of the contract.

B. MODIFICATION OF TERMS AND CONDITIONS:

The CIPET: IPT, Ahmedabad with the consent of the contractor may modify terms and conditions of the contract as and when necessary without affecting the basic nature of his contract post award of contract.
