1. The Tenderer is expected to examine all instructions, forms, terms and specifications in the Tender Documents. 2. The purchaser shall not be liable for any expenses whatsoever incurred by the Tenderer in the preparation of the tender whether his tender is accepted or not even if the purchaser opts for complete withdrawal of invitation of Tender.
3. The Tenderer is advised in his own interest and expense to examine the present School Bags and Safety Shoes at institute premises in CIPET: CSTS, Valsad before submission of the bid.
4. Standard size measurement of Safety Shoes will be provided by CIPET: CSTS, Valsad.
5. Supplier shall be solely responsible for any defect in stitching, quality of material etc. which may result in poor quality.
6. One set of complete School Bag and Safety Shoes along with details of Material used shall be submitted with suitable packing along with the Technical Bid.
7. The label indicating the size of Safety Shoes shall be clearly provided on the packet.
8. Bidder shall submit documentary evidence (signed by authorized signatory) proving that bidder fulfills the criteria as stated in Pre - qualification criteria.
9. Offer should be in two parts Viz., "TECHNICAL BID" and "FINANCIAL BID" and all bids must be submitted through the online portal www.tenderwizard.com/CIPET.
10. Any Tender received after the last date for submission of E-Tenders prescribed in the tender, will be rejected. Conditional tender will be summarily rejected without prejudice so bidders are advised to quote the price as per N.I.T. conditions only.
11. Tenders shall remain valid for 180 days after the date of E-Tender.
