- 12. The Agency may quote their Management/Service charges, in percentage only both in figure and words. Other than service charges, all other tax/ charges will be levied as per the Govt. Norms only.

SPECIAL TERMS AND CONDITIONS

- 15. Manpower for various Works should be made available. The Manpower shall be able to perform various Works as well as field duties.
- 16. The personnel deployed by the Agency will be the employees of the Agency in all respects. The CIPET will not accept any responsibility whatsoever in regard to the personnel provided by the Agency. The firm shall fully indemnify CIPET, Hajipur in this respect.
- 17. The Agency shall ensure the payment of wages to the staff through Bank only.
- 18. The selected Agency has to enter into an Agreement on Non Judicial Stamp of Rs 1000/- at his own cost with the CIPET, Hajipur for one year, which can further be extended twice each time for one year with the consent of both the parties.
