TERMS AND CONDITIONS/INSTRUCTIONS TO BIDDER

- 1. As CIPET is located at 32 locations of country, a list of officials of respective centre will be provided along with the P.O. for supplying the list wise items directly to the respective CIPET centre. E- way bill, if requires will be provided by the respective centre accordingly the invoice shall be raised in the name of respective centre for payment.
- 2. The Bidder is expected to examine all instructions, forms, terms and specifications in the Tender Documents and failure to furnish all information required for the Tender Documents or submission of a Tender not substantially responsive to the Tender Documents in every respect will be at the Tenderer's risk and may result in rejection of the Tender.
- 3. CIPET shall not be liable for any expenses whatsoever incurred by the Tenderer/Bidder in the preparation of the tender whether his tender is accepted or not even if the CIPET opts for complete withdrawal of invitation of Tender.
- 4. The commercially selected L1 bidder has to submit a set of samples to CIPET authorities and obtained their approval before starting of mass production.
- 5. The commercially selected L1 bidder shall be responsible for any defect in stitching, quality of material etc..
- 6. The label indicating the size of shirt & trouser shall be clearly indicated on the packet.
- 7. ."TECHNICAL & FINANCIAL BID" must be submitted through the online portal www.tenderwizard.com/CIPET.
- 8. Tenders shall remain valid for 90 days after the date of E-Tender.
- 9. The supply should be completed within 75 days time.
- 10. In case of work not completed satisfactory or in case of delay, CIPET shall be free to forfeit the EMD.

- 11. The cost of tender document is **Rs. 2,500/-** and Tenderer's is requested to submit the tender fees in the form of Demand Draft drawn in favour of "CIPET" payable at Bhopal on or before 26.08.2019 @ 15.00 hrs.failing which the tender will be rejected.
- 12. The tenderer shall pay Earnest Money Deposit in the form of Demand Draft drawn infavour of "CIPET" payable at Bhopalon or before 26.08.2019 @ 15.00 hrs. The tenders received without the EMD in the prescribed form shall be rejected. The Earnest money of the Unsuccessful tenderers will be refunded within 15 days time from the completion of tender process and issue of Purchase Order.
- 13. The Earnest money of the tenderer shall be forfeited by CIPET without prejudice to another rights or remedies:
- a) If the tenderer withdraws his tender during the period of tender validity specified in the tender document.
- b) If, after acceptance of his tender, the tenderer fails to take up the job.
- c) If, the tenderer fails to sign the contract in accordance with the terms and conditions of the contract.
- d) If, after acceptance of his tender, the tenderer fails to furnish the balance of Security Deposit.
- e) If, after acceptance of his tender, the tenderer fails to commence the work within seven days after receipt of work order to that effect.
 - 14. TDS (Tax Deducted at Source) will be deducted as per prevailing rules and regulations of the Government, if applicable.
 - 15. The Tenderer shall complete the Tender Form and fill the appropriate Technical & Financial Bid furnished in the Tender Documents, indicating for the goods to be supplied, a brief description of the Goods, quantity and prices.
 - 16. The Bidder shall indicate on the Financial Bid attached to these documents, the unit prices and total Bid Prices of the goods, proposed to supply under the Contract.
 - 17. Technical & Financial Bid should be submitted in the prescribed format (Excel Format) given in the Tender Document.
 - 18. The rate quoted by the tenderer should be firm and no escalation on any account whatsoever shall be paid for this work.
 - 19. CIPET will notify the successful tenderer in writing by a registered letter / fax / e-mail to be confirmed that his tender has been accepted.

- 20. Tenderer/supplier has to submit original and three copies of the invoice showing goods description, quantity, unit price, total amount for releasing the payment.
- 21. 100% payment will be paid for supply of Shirts, Trousers, Shoes, Socks and Belts by the respective centres as per actual supply of the quantity. Hence, the suppliers shall be solely responsible for supplying the itmes in the given nos. & sizes and delivery at respective CIPETCentres.
- 22. The required Quantity may be increased / decreased at the sole discretion of CIPET on the same terms and conditions.
- 23. The Principal Director, CIPET:CSTS, Bhopal reserves the right to accept or reject any tender or all tenders at any time prior to award of Purchase Order without assigning any reasons whatsoever and no correspondence shall be entertained in this regard.
