## **INTRODUCTION**

Central Institute of Petrochemicals Engineering & Technology, (CIPET: CSTS, Korba) is a Govt. of India Institute under Department of Chemicals & Petrochemicals, Ministry of Chemical & Fertilizers, Govt. of India. .

CIPET: CSTS, Korba invites tenders in 2 bid system (Technical and Financial Bid) for initially 6 months contract (extendable after 6 months upto maximum of 3 years) to engage the services of a qualified and reputed Doctor to provide medical consultation on monthly visit basis.

## **DETAILS OF REQUIREMNT OF SERVICES**

- To provide medical consultancy services to the employees, students and family members of the center at least 2 times in a week on half day basis in each visit.

## **ESSENTIAL QUALIFICATION & CRITERIA:**

1. MBBS Degree from a recognized university or equivalent qualification, recognized by the MCI
2. Preference will be given to those who are enrolled in other PSU's / working in autonomous bodies / Educational Institutes for similar assignment.
3. Retired doctors may also apply.
4. Preference may be given to MD.

## **APPOINTMENT & TENURE:**

- The engagement shall be purely on temporary basis for a period of 6 months contract (extendable after 6 months upto maximum of 3 years). Further extension shall be reviewed at the end of the contract on satisfactory performance with mutual consent.

## **HOW TO APPLY:**

- Eligible and interested candidates may apply as per the prescribed application format, at Annexure-A & Annexure – B respectively. All relevant documents should be attached with the application. Incomplete application forms shall be summarily rejected.
- The Tenderer should submit his application in two bid system i.e. TECHNICAL BID and FINANCIAL BID. Both the bids should be kept in separate envelopes and those two separate envelopes shall be kept in a sealed envelope.
- The tenderer is expected to examine all instructions, forms, terms and specifications in the Tender Documents. Failure to furnish all information required for the Tender Documents or submission of a Tender not substantially responsive to the Tender Documents in every respect will be at the Tenderer's risk and may result in rejection of the Tender.
