ELIGIBILITY CONDITIONS FOR PARTICIPATION

BASIC ELIGIBILITY

- (a) The applicant should be in catering business (excluding beverage and snacks services) for a minimum period of three years as on 31.01.2019.
- (b) Experience of having successful run of the catering services during the last three years ending 31.01.2019 as per following:
 - 3 similar completed works each having not less than 175 persons on its dining strength.
 - 2 similar completed works each having not less than 250 persons on its dining strength.
 - 1 similar completed works each having not less than 300 persons on its dining strength.
 - *Similar nature of work means the running of the Canteens/messes of institutions/organizations/companies/guest houses.
- (c) Average Financial Turn-Over (Gross)

The bidder's average annual financial turnover (gross) in catering services during the last three financial years, i.e., 2015-16, 2016-17 and 2017-18, duly audited by CA should not be less than 35 Lakhs per year in which no turnover is shown would also be considered for working out the average.

(d) Financial Solvency

The bidder should have solvency of 30% of the cost of the work. A certificate to this effect may be enclosed from the banker.

(e) Performance Certification

The bidders' performance, as per format at Annexure-I for each work completed in the last three years and in hand should be certified by a responsible person from the concerned organization. The certificate should also indicate the compliance of statutory requirements.

(f) Tenders received of incomplete nature or without proper documents, including demand draft, shall be rejected.
